### **FOR YEAR ENDED 31 DECEMBER 2020**

The directors present their annual report and the audited financial statements of the company for the financial year ended 31 December 2020.

The charity is a registered charity and hence the report and results are presented in a form which complies with the requirements of Companies Act 2014 and FRS 102. Although not obliged to comply with the Charities SORP, the charity has implemented its recommendations where relevant in these accounts. The main activities of the charity are charitable.

#### **OBJECTIVES AND ACTIVITIES**

The main objective of the charity is to uplift the most vulnerable members of society, especially disabled and abandoned children and marginalised communities in Jamaica, Nicaragua, Dominican Republic, Zimbabwe and Malawi by supporting Mustard Seed International's projects in these countries through the provision of grants to agreed projects, and by liaising on behalf of Mustard Seed International with Irish Aid, the official Irish government foreign aid agency.

Main activities of the charity include the following:

- Advancement of community welfare including the relief of those in need because of youth, age, ill health, or disability
- Advancement of community development, including rural or urban regeneration
- Promotion of civic responsibility or voluntary work
- Promotion of health, including the prevention or relief of sickness, disease or human suffering
- Promotion of religious or racial harmony and harmonious community relations
- Integration of those who are disadvantaged, and the promotion of their full participation, in society

The charity activities are achieved by the supporting Mustard Seed International projects which activities include the above.

#### **ACHIEVEMENTS AND PERFORMANCE**

During the year to December 2020 Mustard Seed Communities Ireland continued to function well despite the difficult circumstances of the COVID-19 pandemic. 2020 would have marked the eighth year for Mustard Seed Ireland's Annual Dublin Lunch at the Mansion House, however due to government restrictions surrounding the pandemic the physical event had to be postponed. Mustard Seed replaced this event with a Virtual lunch event and appeal ensuring it could continue to support its feeding programme in Zimbabwe.

Mustard Seed has been operating in Zimbabwe since 2003 and its nutrition programme, which runs across four locations in Bulawayo now feeds 1,000 children a day. (Since the onset of the pandemic in March 2020, numbers doubled from 500 to 1,000 children a day attending MSC's nutrition programmes in Zimbabwe). The proceeds received from Annual Lunch donations funds this nutrition programme, in particular the feeding programme at Ngozi Mine, a garbage dump where close to 1,000 people live in subhuman conditions.

Developing the 'Children for Children' Volunteer programme to Jamaica continued to be a big focus for Mustard Seed for 2020 with 120 volunteers recruited to take part in this programme, however travel restrictions as a result of the pandemic meant that all mission trips had to be cancelled.

MSC's fundraising events together with the success of its volunteer programmes enable Mustard Seed to raise awareness for its cause together with much needed funds to enable the charity to continue its work supporting the most vulnerable children in Jamaica, Nicaragua, Dominican Republic, Zimbabwe and Malawi.

Mustard Seed Ireland remains heavily dependent on its volunteer network who make fundraising events possible. Although Mustard Seed Communities Company Limited by Guarantee do not quantify the monetary value of volunteer work (under FRS102 guidelines), the organization is forever indebted to its volunteers for their invaluable contribution to the organisation.

#### **FINANCIAL REVIEW**

##### **Review of financial position**

The statement of financial activities, statement of comprehensive income, statement of financial position and cashflow statement for the year ended 31 December 2020 are set out on pages 10 to 13.

The Board has designated reserves of €97,000 in respect of volunteer groups that did not travel in 2020, but who may consider travelling in 2022, subject to MSC's guidelines and on Covid restrictions.

##### **Principal funding resources**

The principal funding resources for the charity are the donations it receives from the public and corporations. It also receives funding from fundraising and sponsored events it hosts during the year. The charity wishes to thank its supporters during the year, without their supporters the charity would not be able to achieve its objective.

#### **Principal risks and uncertainties**

COVID-19 - To fund its activities the charity is heavily reliant on its fundraising events and donations associated with these events. The current COVID-19 pandemic and associated government control measures means that the charity cannot host these events and as a consequence there is an increased risk that the charity will be unable to raise the necessary funds to allow it to continue its charitable activities. In response to this the directors and volunteers that manage the charity have instigated other income generating activities and are maximising income from these alternative channels to mitigate losses in other areas. The charity is continually monitoring its cashflow and has detailed monthly financial and cashflow projections. Based on these financial and cashflow projections the directors are satisfied that the charity has sufficient cashflow to enable it to continue as a going concern and the accounts have been prepared on this basis.

Regulations and legislation – The charity is a public interest body and is regulated by the charities regulator and also has a CHY number from revenue. The directors continuously monitor development associated with regulation in order to ensure that the charity complies with all rules, regulations and best practise on ongoing basis.

The charity has minimal currency risk and credit risk. The charity has no interest rate risk due to the fact that the charity has no borrowings.

The directors are aware of the key risks to which the charity is exposed, in particular those related to the operations and finances of the charity and are in the process of implementing systems and controls to mitigate these risks

#### **STRUCTURE, GOVERNANCE AND MANAGEMENT**

##### **Governing Document**

Mustard Seed Communities is a company limited by guarantee, and not having a share capital incorporated in the Republic of Ireland under the Companies Act 2014. The company does not have a share capital and consequently the liability of the members is limited, subject to an undertaking by each member to contribute to the net assets or liabilities of the company on winding up such amounts as may be required not exceeding one Euro.

The company was set up under a Constitution which established the objects and powers of the charitable company and is governed under its Constitution and is managed by a Board of Directors.

The company has been formally approved in applying for its CHY number. The charity has received its charity regulatory number from the charity regulatory authority.

##### **Directors**

Mustard Seed Communities is governed by a Board of Directors. All Board members work in a voluntary capacity and do not receive any remuneration or expenses. There were no material contracts or arrangements entered into during the financial year in which a board member was materially interested or which were significant in relation to the company activities.

#### **1. General Information**

These financial statements comprising the Statement of Financial Activities, the Statement of Comprehensive Income, the Statement of Financial Position, the Statement of Cash Flows and the related notes 1 to 13 constitute the individual financial statements of Mustard Seed Communities CLG for the financial year ended 31 December 2020.

Mustard Seed Communities is a company limited by guarantee and not having a share capital, incorporated in the Republic of Ireland. The Registered Office is JPA Brenson Lawlor House, Argyle Square, Morehampton Road, Donnybrook, Dublin 4. The nature of the charities operations and its principal activities are set out in the Director's Report on pages 1 to 6.

#### **Statement of Compliance**

The financial statements have been prepared in accordance with Charities SORP (FRS 102) "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102). The charity constitutes a public benefit entity as defined by FRS 102.

#### **Currency**

The financial statements have been presented in Euro (€) which is also the functional currency of the company.

#### **2. Going Concern**

The charity is substantially dependent on discretionary income to cover its operating expenses and to meet its stated objectives as stated in the director's report. Such income normally takes the form of donations and other funding. The directors believe that income will continue at an adequate level for the foreseeable future so that the company can continue in operational existence. In these circumstances the financial statements are prepared on a going concern basis.

#### **3. Accounting Policies**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

#### **Basis of preparation**

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice-Charities SORP (FRS 102) "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102) and the Companies Act 2014.

##### **Fund Accounting**

The following funds are operated by the charity:

##### ***Restricted Funds***

Restricted funds are to be used for the specified purposes as laid down by the donor/grantor. Expenditure which meets these criteria is allocated to the fund. There was no restricted funds received in the period.

##### ***Unrestricted Funds***

General funds represent amounts which are expendable at the discretion of the directors in furtherance of the objectives of the charity and which have not been designated for other purposes. Such funds may be held in order to finance working capital or capital expenditure.

##### ***Designated Funds***

Directors can designate part or all, of the unrestricted funds for specific purposes. These designations have an administrative purpose only, and do not legally restrict the board's discretion to apply the fund. The directors have designated some reserves of €97,000 in respect of volunteer groups that did not travel in 2020, but who may consider travelling in 2022, subject to MSC's guidelines and on Covid restrictions. There was no unrestricted funds received in the period.

##### **Incoming Resources**

All incoming resources are included in the Statement of Financial Activities (SoFA) when the charity is legally entitled to the income after any performance conditions have been met, the amount can be measured reliably and it is probable that the income will be received.

##### ***Donated Services***

Gifts in kind are valued at the cost that would be incurred if the company engaged the services.

##### ***Donations***

Donations are credited to incoming resources in the year in which they are receivable. Donations received in advance for specified periods are carried forward as deferred income.

##### **Incoming Resources (continued)**

No amount is included in the financial statements for volunteer time in line with SORP (FRS 102).

Where practicable, gifts in kind donated to the charity for distribution to the service users or for resale in charity shops are included in donations in the financial statements at their fair value. If it is impracticable to assess the fair value at receipt or if the costs to undertake such a valuation outweigh the benefits, then the income and associated expenditure is not recognised.

##### **Expenditure Recognition**

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Expenditure is recognised where there is a legal or constructive obligation to make payments to third parties, it is probable that the settlement will be required and the amount of the obligation can be measured reliably. It is categorised under the following headings:

- Costs of raising funds;
- Expenditure on charitable activities; and
- Other expenditure represents those items not falling into the categories above.

##### ***Financial Instruments***

##### **Cash and cash equivalents**

Cash consists of cash on hand and demand deposits. Cash equivalents consist of short term highly liquid investments that are readily convertible to known amounts of cash that are subject to an insignificant risk of change in value.

##### **Other financial liabilities**

Trade creditors are measured at invoice price, unless payment is deferred beyond normal business terms or is financed at a rate of interest that is not a market rate. In this case the arrangement constitutes a financing transaction, and the financial liability is measured at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

**Judgments and key sources of estimation uncertainty**

The directors consider the accounting estimates and assumptions below to be its critical accounting estimates and judgements:

***Going Concern***

The directors have prepared budgets and cash flows for a period of at least twelve months from the date of the approval of the financial statements which demonstrate that there is no material uncertainty regarding the company's ability to meet its liabilities as they fall due, and to continue as a going concern. On this basis the directors consider it appropriate to prepare the financial statements on a going concern basis. Accordingly, these financial statements do not include any adjustments to the carrying amounts and classification of assets and liabilities that may arise if the company was unable to continue as a going concern.

**Taxation**

No charge to current or deferred taxation arises as the charity has been granted charitable status under section 207 and 208 of the Tax Consolidation Act 1997, Charity No CHY 22029. The charity is fully tax compliant.
